EDITORIAL

Invest in the future: Defeat malaria.

Is there a room in this investment for Community Health Workers (CHWs) in achieving the malaria related Millennium Development Goals (MDGs)?

Many countries have resorted to working with CHWs especially in hard to reach communities even though in recent years, CHWs were consider as volunteers with a few elements of motivation. They were integral parts of projects and as soon as the projects ended they disappeared. In some countries, they had the fortune of being co-opted as health auxiliaries by the Ministry of Health. This latter strategy should be encouraged in CARN member countries who should seize the opportunity offered by some donors in supporting CHW projects to co-opt the CHWs as health auxiliaries at the end of the donor funded proiects.

The use of well selected and well trained CHWs, who benefit from quality facilitative supervision, and are regular supplies with materials needed for their community work, give appreciable results in the domain of improvement of the national health information system. They also bring the population closer to the health staff and thereby contribute to the reduction of malaria morbidity and mortality.

Joint mission, RBM/CARN, to Sao Tome and Principe

A mission of the CARN Steering committee made up of Dr. Nilton (NMCP Angola), Pr. Tona (Pharmacovigilance Unit of the School of Pharmacy-University of Kinshasa DRC), Dr. Mulenda (WHO IST Libreville Gabon) and the CARN Coordinator travelled to Sao Tomé between the 11-15 of March. The team discussed with the Minister of Health, members of the National Center for the Fight against Pandemics under whose authority is placed the NMCP, national and international partners including UN Agencies and health facilities staff. Huge challenges lie ahead as the country prepares to undertake its pre elimination phase; however it disposes of enough epidemiological, parasi-

The capture of mosquitoes via human baits carried out in 2012 in 14 sites gave 556 anopheles gambiae inside houses as opposed to 8480 A. gambiae outside houses within the context of an increase in confirmed malaria cases. The results of the molecular identification of these A. gambiae as well as the Elisa tests are highly awaited. Amongst others, CARN recommended that a course on malariology be organized within the country in order to increase the number of service providers who know malaria and that an international conference be organized on "STP towards pre elimination -opportunities and challenges".
